

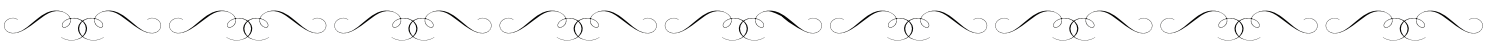

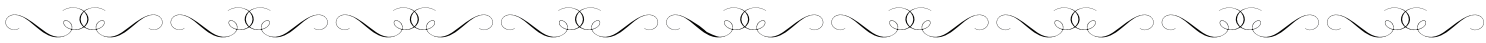

## *CASA of Travis County*

Every year, CASA of Travis County provides advocates to speak up in court for children who have been removed from their homes due to abuse or neglect. CASA recruits, trains, screens and supervises these community volunteers so that they may properly advocate for the best interest of the child. These Court Appointed Special Advocates are often recognized as the one person during court proceedings who truly understands the child and the situation. In 2008, we served approximately 75% of the more than 1,500 children in need; yet even one child left without an advocate is unacceptable in our eyes, and we know is unacceptable in yours as well.
